Biography

Hrvoje Jurić was born on August 4, 1975 in Bihać (Bosnia and Herzegovina), where he finished elementary school (1981–1989) and secondary school, i.e. gymnasium (1989–1993). From 1993 to 1998 he studied Philosophy and Croatian Studies at the University Centre of Croatian Studies, University of Zagreb, where he graduated with a MA thesis on *Practical Philosophy and Philosophical Hermeneutics of Hans-Georg Gadamer* (supervisor: Prof. Ante Pažanin, PhD). In the academic year 1995/1996 he received the University of Zagreb Rector's Award and in the academic years 1995/1996 and 1996/1997 he received the scholarship of the City of Zagreb. In the academic year 1998/1999 he enrolled in the postgraduate study of Philosophy at the Faculty of Humanities and Social Sciences, University of Zagreb, where he received PhD degree in 2007, defending his dissertation on *Hans Jonas's Ethics of Responsibility* (supervisor: Prof. Ante Čović, PhD).

Since 2000, he has been employed at the Department of Philosophy, Faculty of Humanities and Social Sciences, University of Zagreb, first as a Research Assistant in the project "Bioethics and Philosophy", and later as a Junior Teaching Assistant, Teaching Assistant, and Senior Teaching Assistant at the Chair of Ethics. On November 12, 2009, he was appointed as an Assistant Professor, on December 18, 2013 as an Associate Professor, on October 15, 2019 as a Full Professor, and on February 21, 2025 as a Full Professor with Tenure in the scientific area of Humanities, the scientific field of Philosophy, and the scientific branch of Ethics. Since his employment at the Department of Philosophy, he has continuously participated in the teaching of ethical and bioethical courses at the undergraduate and graduate studies of Philosophy, innovating the contents of existing courses and designing new ones. Since the academic year 2012/2013, he is also a lecturer at the Postgraduate Doctoral Studies of Philosophy at the Faculty of Humanities and Social Sciences, University of Zagreb.

From the academic year 2015/2016 to the academic year 2024/2025 he was the head of the Chair of Ethics at the Department of Philosophy, Faculty of Humanities and Social Sciences, University of Zagreb. From the academic year 2016/2017 to the academic year 2019/2020 he was the head of the Department of Philosophy, and from the academic year 2020/2021 he is the head of the Doctoral Studies of Philosophy at the Faculty of Humanities and Social Sciences, University of Zagreb.

From 2010 to 2026 he was a supervisor of 99 defended MA theses and 12 defended PhD theses in the scientific field of Philosophy at the Faculty of Humanities and Social Sciences, University of Zagreb, while several more MA and PhD theses are being prepared under his supervision. He was also the supervisor of one PhD thesis in the scientific field of Philosophy at the Faculty of Philosophy in Nikšić, University of Montenegro. Furthermore, under his supervision a doctoral dissertation in the field of philosophy is currently being prepared at the Faculty of Croatian Studies, University of Zagreb (Croatia), as well as another in the same field at the Faculty of Philosophy, University of Novi Sad (Serbia) with him as a co-supervisor. He was also a supervisor of two defended MA theses at the University of Applied Health Sciences in Zagreb (specialist graduate study of Environmental Health Engineering).

He is the initiator and long-term mentor of student bioethics workshops held since 2005 as a part of the international scientific and cultural conference *Lošinj Days of Bioethics*. In 2009 he was co-mentor of the student section within the international symposium "Philosophy and Media" at the international scientific and cultural conference *18th Days of Frane Petrić* in Cres. In 2013 he mentored seven graduate and postgraduate students from the Faculty of Humanities and Social Sciences, University of Zagreb who participated in the ERASMUS summer school *Bioethics in Context II: Autonomy, Dignity, and Life as Fundamentals in Bio- and Medical Ethics* in Rethymno (Greece), and each year since 2016 he mentored three to five postgraduate students from the Faculty of Humanities and Social Sciences, University of Zagreb, who participated in the summer schools *Bioethics in Context* in Tutzing (Germany) 2016, Kiten (Bulgaria) 2017, Tutzing (Germany) 2018, Trogir (Croatia) 2019,

Berlin (Germany) 2020, Tutzing (Germany) 2021, Zagreb (Croatia) 2022, Tutzing (Germany) 2023, Thessaloniki (Greece) 2024, Linz (Austria) 2025, and Rethymno (Greece) 2026. In the academic year 2016/2017 he was the supervisor of a collaborative work that won the University of Zagreb Rector's Award.

Since 2008 he is a guest lecturer at the School of Medicine, University of Zagreb (undergraduate study of Medicine, undergraduate study of Medicine in English, graduate study of Nursing, postgraduate doctoral study of Public Health, postgraduate doctoral study of Neuroscience), since 2011 at the University of Applied Health Sciences in Zagreb (specialist graduate study of Environmental Health Engineering), at the Faculty of Law, University of Split (specialist postgraduate study of Medicine and Law, 2010/2011 and since 2019), and since 2021 at the Amigdala Centre in Zagreb (program "Propaedeutics of Psychotherapy"). As a guest lecturer, he also gave lectures at the Centre for Women's Studies in Zagreb from 2011 to 2017 (educational programme "Women's Studies"), at the Academy of Fine Arts, University of Zagreb (graduate study, 2011/2012), at the Faculty of Law, University of Bihać (undergraduate study, 2013), and in the NGO GONG in Zagreb (educational programme "Civic Literacy", 2012). Within the CEEPUS network "Philosophy and Interdisciplinarity", he was a guest lecturer at the universities of Tuzla, Bosnia and Herzegovina (April 2018), Zenica, Bosnia and Herzegovina (April 2019), Skopje, North Macedonia (April 2021 and April 2024), and Tetovo, North Macedonia (April 2022). In the winter semester of the academic years 2020/2021 and 2023/2024 he was a visiting professor at the Catholic Private University Linz, Austria, as a lecturer and a holder of the course "Bioethics: Historical and Topical Approach".

As a research assistant and a research associate, he participated in the implementation of four scientific research projects funded by the Ministry of Science, Education and Sports of the Republic of Croatia: "Bioethics and Philosophy" (2000–2002; project leader: Prof. Ante Čović, PhD), "Bioethics and Philosophy" (2002–2005; project leader: Prof. Ante Čović, PhD), "Foundation of Integrative Bioethics" (2007–2013; project leader: Prof. Ante Čović, PhD), and "Cultural Animalistics: Literary, Folklore, Ethnological and Cultural Anthropological Contributions" (2011–2013; project leader: Antonija Zaradija Kiš, PhD). From 2006 to 2011 he was a collaborator of the international scientific research project "Bioethik im südosteuropäischen Raum: Chancen, Probleme und praktische Perspektiven der Konstitution öffentlicher ethischer Diskurse unter Umbruchsbedingungen" and the international scientific programme "Südosteuropäisches Netzwerk 'Integrative Bioethik'", whose leaders were Prof. Walter Schweidler, PhD and Prof. Ante Čović, PhD, and funded by the German foundations DAAD and Volkswagen. In 2006 and 2007 he was a collaborator of the international scientific research project "Gender Stereotypes in Science in South Eastern European Countries" (coordinator: Prof. Marina Calloni, PhD), funded by UNESCO. Since 2013 he is a collaborator in the international project "Bioethik im Kontext / Bioethics in Context" (coordinator: Prof. Thomas Sören Hoffmann, PhD), funded by the European Commission, the German DAAD Foundation, and the Academy for Civic Education in Tutzing, Germany. In 2012 and 2013 he participated as an associate in the scientific research project "Integrative Bioethics: Founding a Centre of Excellence and Postgraduate Doctoral Studies at the University of Zagreb" (project leader: Prof. Ante Čović, PhD), funded by the Development Fund of the University of Zagreb. He was also a collaborator in the following two international scientific research projects: "Disaster Bioethics: Addressing Ethical Issues Triggered by Disaster" (2012–2016; COST Action IS1201; project leader: Dónal O'Mathúna) and "Big Data im Diskurs" (2017–2019; funded by the German Federal Ministry of Education and Research; project leader: Prof. Michael Spieker, PhD), as well as the national projects "Roots of Bioethics: American and European Contributions to the Construction of a Unique History" (2014–2017; funded by the University of Rijeka, project leader: Prof. Amir Muzur, PhD) and "Green Policies, Grey Zones: Environmental Justice Between Ideals and Reality in the Croatian and Comparative European Context" (2025–2029; Faculty of Humanities and Social Sciences, University of Zagreb; project leader: Assoc. Prof. Tijana Trako Poljak, PhD). He is also a member of the international research network "Navigating Knowledge Landscapes".

He was a project leader of nine scientific research projects conducted at the Faculty of Humanities and Social Sciences, University of Zagreb, funded by the University of Zagreb: "Theoretical Foundations

and Practical Implications of European Bioethics” (2015, 2016, 2017 and 2018), “The Relationship Between Nature and Culture in the Perspective of Integrative Bioethics” (2019), “Health and Knowledge in the Perspective of Philosophy and Information Sciences: An Example of the Coronavirus Pandemic” (2020), “Systematization, Analysis, Interpretation, and Critique of the Reviews of Coronavirus Pandemic Issues in Croatian Humanities and Social Sciences Literature” (2022 and 2023), and “Philosophy of Immanuel Kant in Contemporary Contexts” (2024). Together with Prof. Thomas Sören Hoffmann, PhD, he was a project leader of the international scientific research project “Öffentliches Gesundheitswesen und die Herausforderungen des epidemiologischen Notstands aus Sicht der Integrativen Bioethik: Ein deutsch-kroatischer Ländervergleich” (2021–2022), funded by the Croatian Ministry of Science and Education and the German DAAD Foundation. Together with Prof. Tomaž Grušovnik, PhD, he was a project leader of the international scientific research project “Animal Ethics: Towards a Sustainable Transspecies Community” (2023–2024), funded by the Croatian Ministry of Science and Education and the Slovenian Research and Innovation Agency.

Since its founding in 2013, he has been an associate and secretary of the Centre for Integrative Bioethics at the Faculty of Humanities and Social Sciences, University of Zagreb, whose head he became in 2018. From 2014 to 2024 he was an associate and a chief secretary (and since 2018 a deputy director) of the Croatian Centre of Excellence for Integrative Bioethics, proclaimed by the decision of the Minister of Science, Education and Sports of the Republic of Croatia, which embraced seven Croatian bioethical institutions and more than 100 scientists from Croatia and abroad. Since its founding in 2017, he is a head of the University Centre for Integrative Bioethics at the University of Zagreb.

Twice (in 2005 and 2007) he was on a study visit to the Ruhr University Bochum (Germany).

He has participated with his own papers in more than 200 Croatian and international scientific conferences, and attended about 20 other Croatian and international scientific conferences as a discussant. In addition, he has given more than 100 public lectures on philosophical, scientific and social-political topics in Croatia and abroad, and participated as a speaker at numerous panels and book presentations.

During his undergraduate studies, he was one of the founders and assistant editor (1996–1997) and editor-in-chief (1997–1998) of *Scopus*, a philosophical journal of the students of the University Centre of Croatian Studies, University of Zagreb, as well as a member of the editorial board of the *Scopus Book Series* (1997–1998). From 1999 to 2006 he was an assistant editor of the academic journals *Filozofska istraživanja* and *Synthesis philosophica*, and the *Filozofska istraživanja Book Series*, published by the Croatian Philosophical Society, and from 2006 to 2025 he was a deputy editor of the journals and the book series. Since 2026 he is a president of the Advisory Board of the journals *Filozofska istraživanja* and *Synthesis philosophica*. From 1998 to 2004 he was an executive editor of the *Bioetika Book Series* in the publishing house Pergamena in Zagreb, and since 2025 he is a chief editor of this book series. He is also a member of the editorial boards of the following academic journals: *Jahr – European Journal of Bioethics* from Rijeka, Croatia (from its founding in 2010 to 2021, and since 2021 a member of the Journal’s Advisory Board), *The Holistic Approach to Environment* from Sisak, Croatia (since its founding in 2011), *In medias res* from Zagreb, Croatia (from its founding in 2012 to 2020), *Journal of Applied Health Sciences* from Zagreb, Croatia (since its founding in 2015), *Radovi Filozofskog fakulteta u Sarajevu* from Sarajevo, Bosnia and Herzegovina (since 2018), *Znakovi vremena* from Sarajevo, Bosnia and Herzegovina (since 2022), *JAIH – Journal of Artificial Intelligence Humanities* from Seoul, South Korea (since 2023), *Anthropos* from Ljubljana, Slovenia (since 2023), and *Historical Searches* from Sarajevo, Bosnia and Herzegovina (since 2026), as well as a member of the Editorial Board of the online magazine *H-alter* (2005–2010) and the Advisory Board of the magazine *Novi Plamen* (2007–2012).

He was an editor of more than 60 conference publications for Croatian and international scientific conferences, mostly those organized by the Croatian Philosophical Society and the Croatian Bioethics Society, as well as several other publications.

He edited ten thematic blocks in the journal *Filozofska istraživanja* and four thematic blocks in the journal *Synthesis philosophica*, and one thematic block in each of the following journals: *Scopus*, *Quorum*, *Holon*, and *Sarajevske sveske*.

From 2003 and 2009 he authored seven thematic cycles within the radio show “Zoofon” [Zoophone] at the Third Programme of the Croatian Radio (editor: Giga Gračan), and in 2002 and 2003, together with Tonči Matulić, he was an editor and a host of nine TV shows under the title “Dvogled – etika, bioetika” [Binoculars – Ethics, Bioethics] at the First Programme of the Croatian Television.

As a peer reviewer, he has written more than hundred peer reviews of scientific articles and books for Croatian journals and publishers.

From 2002 to 2006 he was a chief secretary, and since 2007 a member of the Organization Committee of the international scientific and cultural conference *The Days of Frane Petrić*, organized by the Croatian Philosophical Society and held every year in Cres, Croatia. In 2021 and 2022 he was a president of the Organization Committee of *The Days of Frane Petrić*. Since its founding in 2002 to 2025, he was a chief secretary of the international scientific and cultural conference *The Lošinj Days of Bioethics*, organized by the Croatian Philosophical Society, the Croatian Bioethics Society, and the Town of Mali Lošinj, and held every year in Mali Lošinj, Croatia. Since 2026 he is a president of the Organization Committee of *The Lošinj Days of Bioethics*. From 2008 to 2010 he was a coordinator of the international conference *Südosteuropäisches Bioethik-Forum / Southeast European Bioethical Forum* (Opatija, Croatia, 2008; Sarajevo, Bosnia and Herzegovina, 2009; Belgrade, Serbia, 2010). He was also a member of organization and programme committees of more than thirty Croatian and international scientific conferences, secretary of organization and programme committees of more than twenty international scientific conferences, and president of the organization committees of more than ten Croatian and international conferences. In 2009, 2010, 2011 and 2013 he was an author and a leader of the project “Bioethics – Issues of Life and Death” at the Trešnjevka Cultural Centre in Zagreb, which included public lectures and discussions on the bioethics issues.

He is a member of the Croatian Philosophical Society since 1999. In 1999 and 2000 he was a member of the Steering Committee and a secretary of the Croatian Philosophical Society, from 2002 to 2021 he was an administrative secretary of the Croatian Philosophical Society, and in 2021 and 2022 he was a president of the Croatian Philosophical Society. Since 2007 he is a member of the International Cooperation Board of the Croatian Philosophical Society, and since he is 2012 a member of the Archives Board of the Croatian Philosophical Society. Since its founding in 2000, he is a member of the Croatian Bioethics Society. From 2012 to 2016 he was a member of the Steering Committee of the Croatian Bioethics Society, since 2013 he is a head of the Zagreb Branch of the Croatian Bioethics Society, and from 2016 to 2020 he was a president of the Croatian Bioethics Society. Since its founding in 2001, he is a member of the Croatian Society for Analytic Philosophy. He is also, since 2011, an honorary member of the Bioethical Society of Serbia.

Since 2007 he is a member, and from 2013 to 2020 he was also a president of the State Commission for the Implementation of Philosophy Competitions of the High School Students at the Croatian Education and Teacher Training Agency, where he participates in the development and reviewing the tests and conducting the tests at the school, county and state levels, as well as in the process of selecting the candidates for the International Philosophy Olympiad. From 2006 to 2009 he was a member of the expert commissions for the evaluation of the Philosophy and Ethics highschool textbooks at the Ministry of Science, Education and Sports of the Republic of Croatia. In 2015 and 2016 he was a member of the expert working groups for the development of Philosophy and Ethics high school curricula as part of the Comprehensive Curriculum Reform. He is the co-author of the philosophy textbook, which has been used as one of three philosophy textbooks in secondary schools

(gymnasiums) in the Republic of Croatia since 2021, in two editions, and with the approval of the Ministry of Science and Education.

He has been a member of the Faculty Council of the Faculty of Humanities and Social Sciences, University of Zagreb from 2004 to 2014 (from 2004 to 2009 as a representative of research and teaching assistants, and from 2009 to 2014 as a representative of the Department of Philosophy), from 2016 to 2020 (as a head of the Department of Philosophy) and again from 2020 to 2025 (as a representative of the Department of Philosophy).

From 2009 to 2017 he was a member of the Ethics Committee of the Faculty of Humanities and Social Sciences, University of Zagreb, which he became again in 2021, and from 2011 to 2021 he was a member of the Ethics Committee for Scientific Research of the Faculty of Humanities and Social Sciences, University of Zagreb. From 2015 to 2017 he was a member of the Students Disciplinary Board at the Faculty of Humanities and Social Sciences, University of Zagreb, and from 2017 to 2019 he was a member of the Disciplinary Board at the Faculty of Humanities and Social Sciences, University of Zagreb. Since 2009 he is a member of the Ethics Committee of the Zagreb Rehabilitation Center. For a short period in 2013, he was a member of the Anti-Corruption Council at the Croatian Health Insurance Fund. From 2019 to 2024 he was a member of the Ethics Council of the University of Zagreb. Since 2021 he is a member of the University Council of Social Sciences and Humanities. From 2021 to 2024 he was a president of the Scientific Field Committee for Philosophy and Theology at the National Council for Science, Higher Education and Technological Development of the Republic of Croatia.

In 2013 he was a member of the working group for drafting the proposal of the National Youth Programme 2014–2017 at the Croatian Ministry of Social Policy and Youth. From 2006 to 2009 he was a member of the Steering Committee of the NGO *CESI – Centre for Education, Counselling and Research*, and from 2009 to 2013 a member of the Supervisory Board of the same NGO. Since 2011 he is a member of the Advisory Board of the NGO *Animal Friends Croatia*.

He has collaborated in various ways with some other scientific, cultural and social organizations, initiatives and projects. He is also a regular guest as an expert in various radio and television shows and has given a large number of interviews and statements to Croatian and international media.

Areas of his scientific and professional interest are: practical philosophy, ethics, bioethics, philosophy of technology, philosophy of nature, philosophy of media, philosophical hermeneutics, feminist and gender theory, and social-political issues.
